Sir,

The PGDM program offered by Institute of Technology and Science, Mohan Nagar, Ghaziabad, Uttar Pradesh was accredited by NBA for a period of three years for the Academic Years 2019-20 to 2021-22 i.e. upto 30-06-2022 vide NBA's letter No. 35-18-2010/NBA dated 14-01-2020. However, after the guidelines of AICTE through their Approval Process Hand Book 2020-21, the PGDM program has been separated and shifted to a new PGDM Institute namely "I.T.S. School of Management" from the Session 2020-21.

2. An Expert Team conducted on-site spot verification of facts mentioned by the Institute on 30<sup>th</sup> June, 2021. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The competent authority in NBA has approved the following transfer of accreditation period of the program as given in the table below:


3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to I.T.S School of Management, Mohan Nagar, G. T. Road, Mohan Nagar, Ghaziabad- 201 007, Uttar Pradesh as a whole. As such, the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the date from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

5. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.
